
### **Results of periodical surveillance or re-assessment of the quality system are a part of this notification.**



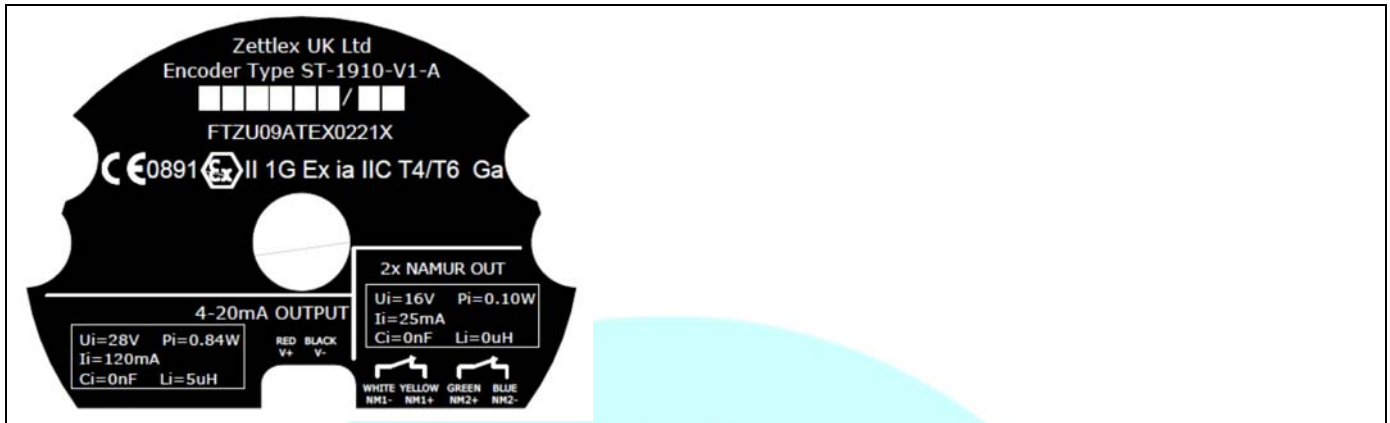
